Effects of Overexposure:

VI. SPILL OR LEAK PROCEDURES

Steps to Be Taken in Case Material Is Released or Spilled:

Ventilate area and remove ignition sources. Dike spill, absorb with inert material, and collect to disposal. Flush area with water. Prevent washings from entering waterways. Spills or releases to the environment may be reportable to the National Response Center, (800) 424-8802, and to state and/or local agencies.

Waste Disposal Method:

VII. SPECIAL PROTECTION INFORMATION

Respiratory Protection:

Wear a properly fitted NIOSH/MSHA approved respirator whenever exposure to vapor/mist is likely unless levels are below applicable limits.

Ventilation:

Local Exhaust - Recommended when appropriate to control employee exposure.

Mechanical - Not recommended as the sole means of controlling employee exposure.
